A regular meeting of the Stanton Community Schools Board of Education was convened in open and public session on Monday February 14, 2011 at 5:00 p.m. in the High/Middle School Library, at the Stanton Community High School, 1007 Kingwood, Stanton, Nebraska. The meeting was called to order by President Michael Marotz.

Roll call was taken and the following board members were present: Rod Zoubek, Brian Nordby, Michael Marotz, John Mandl, and Dean Quinn. Absent: Mark Christensen. Also present Michael Sieh, Chris Stogdill, Mary McKeon and Kim Hoehne.

President Michael Marotz announced the location and informed the public of the current copy of the Open Meetings Act posted in the Library meeting room.

Motion was made by John Mandl, seconded by Brian Nordby to declare the meeting open and properly posted and/or published by advance notice in accordance with board policy #8342 with the notice and advance agenda given to the President of the board and all members prior to the meeting date. Motion was made by John Mandl, seconded by Rod Zoubek to recognize the Stanton Education Association as the exclusive bargaining agent for the certified teaching staff of the Stanton Community Schools 2011-2012 Negotiated Agreement. AMPVF-MC.

Motion was made by Mark Christensen, seconded by John Mandl to renew the board's membership with the Nebraska Association of School Boards for the 2011-2012 school year. AMPVF-MC.

Motion was made by Dean Quinn, seconded by John Mandl to appoint Mark Christensen to the board of directors for the Stanton Community Schools Foundation. AMPVF-MC

Motion was made by Mark Christensen, seconded by John Mandl to adopt the Resolution on the CIR and Helping Local Boards. AMPVF-MC.

Motion was made by Mark Christensen, seconded by Dean Quinn to a) approve & authorize payment for District #3 bills and all late bills presented at this meeting; b) accept the Activity Account Reports; c) accept the Treasurer's Report; d) accept the Board Summary Report; and e) accept the Summary Statement of Revenue. AMPVF-MC.
