A regular meeting of the Stanton Community Schools Board of Education was convened in open and public session on Tuesday, March 13, 2007 at 7:00 p.m. in the High/Middle School Library, at the Stanton Community High School, 1007 Kingwood, Stanton, Nebraska. The meeting was called to order by President Michael Marotz. Roll call was taken and the following board members were present: John Mandl, Rod Zoubek, Michael Marotz, Al Wolverton, and Brian Nordby. Absent: Dean Quinn. Also present were Michael Sieh, Mary McKeon, Chris Stogdill, Kim Hoehne and four guests.

President Michael Marotz announced the location and informed the public of the current copy of the Open Meetings Act posted in the Library meeting room.

Motion was made by Al Wolverton, seconded by John Mandl to declare the meeting open and properly advertised by advance notice in the Stanton Register. Notice of the meeting was given in advance by publication in accordance with the Board approve method for giving notice of meetings. Motion was made by Brian Nordby, seconded by John Mandl to congratulate the State Qualifiers in Wrestling; Robbie Johnson, Paul Cheyney, and Tanner Timperley and State Medalists; Robbie Johnson -5<sup>th</sup> place and Tanner Timperley - 5<sup>th</sup> place; and their coaches Tom King, Al Smidt and Randy Hansen. Motion was made by Al Wolverton, seconded by John Mandl that the Board holds a closed session at 9:15 p.m. for personnel and the evaluation of job performance clearly necessary for the protection of the public interest or for the prevention of needless injury to the reputation of an individual in compliance with the law.
