All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to the attendance of the public. Abbreviations: AMPVF- All members present voted for, MC- Motion carried.

A regular meeting of the Stanton Community Schools Board of Education was convened in open and public session on Monday, November 14, 2016 at 7:00 p.m. in the High/Middle School Library, at the Stanton Community High School, 1007 Kingwood, Stanton, Nebraska. The meeting was called to order by Treasurer Bret Burtwistle.

The Oath of Office was taken by Ryan Wehrle.

Roll call was taken and the following board members were present: Wendy Benson, Bret Burtwistle, Shad Pohlman and Ryan Wehrle. Absent John Mandl, Kirk Van Pelt: Also present were Michael Sieh, David Cunningham, and Kim Hoehne.

The Pledge of Allegiance was recited by all present. Treasurer Bret Burtwistle announced the location and informed the public of the current copy of the Open Meetings Act posted in the Library meeting room.

Motion was made by Shad Pohlman, seconded by Wendy Benson to declare the meeting open and properly posted by advance notice in accordance with board policy #8342 with the agenda given to the President of the board and all members prior to the meeting date. AMPVF-MC.

A public forum was held. A correspondence was read, guests were welcomed.

Superintendent Michael Sieh presented the Elementary Principal's report and reported on the Veteran's Day program, fire prevention week, and completion of fall MAP testing.

Secondary Principal David Cunningham presented the annual comprehensive technology report and reported on a coaching resignation, a non-teaching coaching contract, the school Christmas party, the recognition of state qualifiers and placers, and the start of winter activities. FFA Advisor Morgan Schwartz and five members presented a report on the National FFA convention.

Superintendent Michael Sieh reported on facility planning, middle/high school roof specifications, disposal of the 2001 Dodge van, certified staff negotiations, financial priorities, and monthly bills. He also distributed the superintendent's evaluation instrument.

Motion was made by Wendy Benson, seconded by Bret Burtwistle to accept the resignation of Justin Heng from the position of assistant junior high basketball coach. AMPVF-MC.

Motion was made by Shad Pohlman, seconded by Wendy Benson to approve the assistant junior high wrestling contact between the school district and Tanner Timperley for the 2016-2017 school year. AMPVF-MC.

Motion was made by Bret Burtwistle, seconded by Wendy Benson to recognize the Girls' Cross Country Team (Tenna Beel, Zaynab Kouatli, Josilyn Padilla, Bailey Patterson, Amara Sholes and Alex Thelen), the Boys' Cross Country Team (Shay Bulson, Trenton Cadwallader, Ryan Colson, Trevor Doffin, Broderick Sieh and Parker Zach) and Coach David Ernesti for qualifying for the State Cross Country Meet; and to congratulate Trenton Cadwallader for placing 2<sup>nd</sup> and Trevor Doffin for placing 12<sup>th</sup> at the Boys' State Cross Country Meet.
