Availability of the agenda was communicated in a posted and/or advertised notice and current copy of the agenda was maintained as stated in the notice. All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to the attendance of the public. Abbreviations: AMPVF- All members present voted for, MC- Motion carried.

A regular meeting of the Stanton Community Schools Board of Education was convened in open and public session on Monday, April 10, 2017 at 7:00 p.m. in the High/Middle School Library, at the Stanton Community High School, 1007 Kingwood, Stanton, Nebraska. The meeting was called to order by President John Mandl.

Roll call was taken and the following board members were present: Wendy Benson, Sarah Klinetobe, John Mandl, Shad Pohlman, and Tim Reese. Absent: Colleen Butterfield. Also present were Michael Sieh, Mary McKeon, David Cunningham, and Kim Hoehne.

The Pledge of Allegiance was recited by all present. President John Mandl announced the location and informed the public of the current copy of the Open Meetings Act posted in the Library meeting room.

Colleen Butterfield joined the meeting at 7:01 p.m.

Motion was made by Wendy Benson, seconded by Sarah Klinetobe to declare the meeting open and properly posted and/or published by advanced notice in accordance with board policy #8342 with the agenda given to the president of the board and all members prior to the meeting date. AMPVF-MC.

Motion was made by Shad Pohlman seconded by Tim Reese to approve the board agenda. AMPVF-MC.

Minutes from the March 13, 2017 regular board meeting were approved and accepted by the Secretary.

A public forum was held. Guests were welcomed. A thank you was read.

Elementary Principal Mary McKeon reported on additional employment contracts for summer school and Kindergarten roundup.

Secondary Principal David Cunningham reported on certified staff contracts, driver's education contract, additional paraprofessional/secretary, recognition of state qualifiers, medalists, & all-state students.

Superintendent Michael Sieh gave the annual Governance, Americanism & Wellness comprehensive report. He also reported on middle/high school roof bids, scheduled annual walk around, community

forum discussion, additional employment contracts, monthly bills, upcoming workshops, and movement of the July regular board meeting from July 10th to July 13th.

Motion was made by Wendy Benson, seconded by Shad Pohlman to approve the Additional Employment Contracts between the school district and Janelle Peter, Sharon Schroder, and Shellie Sieh for Summer School. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Colleen Butterfield to approve the contract between Megan Olsen and the Stanton Community Schools for the position of middle school special education Instructor for the 2017/2018 school year. AMPVF-MC.

Motion was made by Tim Reese, seconded by Shad Pohlman to approve the driver's education contract between the school district and Tom King for the summer of 2017. AMPVF-MC.

Motion was made by Colleen Butterfield, seconded by Wendy Benson to recognize Logan McKeon, Ag Communications, Agronomy, State Degree & Crop Production Proficiency; MacKenzie Brandl, Floriculture & State Degree; Trenton Cadwallader, Floriculture, State Degree & Poultry Production Proficiency; Alex Schellpeper, Welding, Ag Communications & Agronomy; Trevor Doffin, Vegetable Production Proficiency, Agronomy & Floriculture; Alyna Padilla, Outdoor Recreation Proficiency; Marcus Spotanski, Electrical Technology Proficiency; Beau Wilke, Welding; Adam Dover, Forage Production Proficiency, Welding & Agronomy; Hunter Voecks, Ag Mechanics; Korbin Voecks, Ag Mechanics; Amanda Schmidt, Ag Mechanics & Vet Science Proficiency; and Ben Hansen, Ag Mechanics & Ag Communications for qualifying for state FFA along with their sponsor Morgan Schwartz; and to recognize Mackenzie Brandl & Bree Burtwistle, Girls' Basketball; Henry Bohac & Broderick Sieh, Boys' Basketball; Mason King Wrestling; and Broderick Sieh, Speech for Academic All-State Awards. Motion was made by Wendy Benson, seconded by Sarah Klinetobe to a) approve & authorize payment for District #3 bills presented at this meeting; b) accept the Activity Account Reports; c) accept the Treasurer's Report; d) accept the Account Summary Report; and e) accept the Revenue Report. AMPVF-MC.

The community forum will be April 12, 2017 at 7:00 p.m. in the elementary gym. The next regular monthly meeting will be May 8, 2017 at 7:00 p.m. in the High School /Middle School Library. The meeting was duly adjourned at 8:46 p.m.
